in consideration of Ten Dollars (\$10.00), love, and affection, Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Dorothy M. Ham, her heirs and assigns forever, all that piece, parcel or tract of land lying, being and situate in the County and State aforesaid and in Oaklawn Township containing 1.5 acres, more or less, and designated as Tract #6 of the property of W. S. Meekins Estate as shown on a plat prepared by C. O. Riddle, Surveyor, in January 1961, and having the following metes and bounds, to wit: beginning at an iron pin in the eastern edge of the Chapman Grove Road, corner with lands of A. M. Stewart; thence with the Chapman Grove Road N 25 - 45 W 241.7' to a point in the center of said road; thence N 64 - 15 W crossing an iron pin 23.7' from said beginning point along the joint line of Tract #5, the total distance of 303.9' to an iron pin, back joint corner with Tract #5 on line of Tract #4; thence with the joint line of Tract #4 S 25 - 45 E 188' to an iron pin on line of land of A. M. Stewart, corner with Tract #4 of said Meekins Estate; thence S 54 - 10 W along the joint line of A. M. Stewart land 308.7' to point of beginning, and bounded by Tracts #5 and #4 of said Meekins Estate land, lands of A. M. Stewart, Chapman Grove Road, and lands of James T. Stewart across said road.

This being a portion of the same tract of land conveyed to me by deed of Washington T. Meekins, et al., on the fourth day of January 1961, to be recorded, in which they conveyed to me their undivided interest as heirs and distributees of W. S. Meekins, deceased, I having inherited the other interest in said property as widow of the said W. S. Meekins.

I reserve for myself the use and occupancy of the within conveyed premises for the term of my natural life.

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s') heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
