unto Mrs. J. M. Page, her heirs and assigns forever:

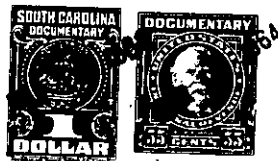
ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, situated just below the town of Piedmont, South Carolina, being known and designated as Lot No. 75, of a subdivision known as Monticello Estates, as shown by a plat thereof, by Woodward Engineering Company, dated March 1956, and recorded in the R. M. C. Office for Greenville County in Plat Book EE, at Page 169, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on North Monticello Road, joint front corners of Lots Nos. 74 and 75 and running thence along the lines of said lots, N. 19-40 E. 200 feet to iron pin; thence running with rear line of Lot 75, S. 70-20 E. 83.23 feet to iron pin rear corner of Lot 76; thence running with line of said lot, S. 19-40 W. 200 feet to iron pin on North Monticello Road; thence running with North Monticello Road, N. 70-20 W. 83.23 feet to iron pin point of beginning.

NO residence to cost less than Five Thousand (\$5,000.00) Dollars shall be erected on any lot; no residence shall be erected on lots nearer than forty (40) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS conveyance is subject to all easements and rights of way of record.
