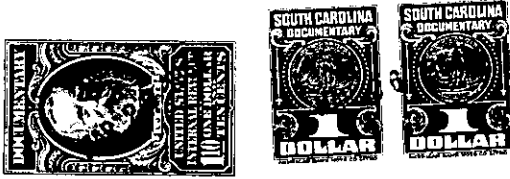

BEGINNING at an iron pin on Wildwood Drive, joint front corners of Lots Nos. 99 and 100 and running thence along the lines of said lots, S. 34-45 W. 200 feet to iron pin; thence running with rear line of Lot 100, N. 55-15 W. 85 feet to iron pin rear corner of Lot 101; thence running with line of said lot, N. 34-45 E. 200 feet to iron pin on Wildwood Drive; thence running with Wildwood Drive, S. 55-15 E. 85 feet to iron pin point of beginning.

NO residence shall be built on any lot costing less than Seven Thousand Five Hundred (\$7,500.00) Dollars; no residence shall be built on said lots nearer than twenty-five (25) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.
