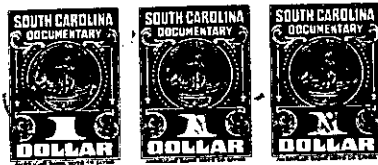

in consideration of Thirteen Hundred and no/100 ----- (\$1300.00) --- Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto W. N. Leslie, Inc.

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, known and designated as lot #79, part of Avon Park, according to plat by C. C. Jones, dated November 1956, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book KK, at Page 71, and having, according to said plat the following metes and bounds:

BEGINNING at an iron pin on the western side of Avon Drive at the joint front corner of lots #79 and #78, running thence along the line of said lots S84-18W 175' to an iron pin; running thence S5-42W 80' to an iron pin; running thence N84-18E 175' to an iron pin on the western side of Avon Drive and running thence N5-42E 80' to an iron pin, point of beginning.
