All that lot of land, situate on Rockingham Road in Greenville County, State of South Carolina, being shown as LOT NO. 64 ROCKINGHAM ROAD, on plat of Barksdale subdivision made by Dalton & Neves, Engineers, December 1959, recorded in the R. M. C. Office for Greenville County S. C. in Plat Book QQ, Pages 118-119 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on Rockingham Road, joint front corner of Lots 64 and 65 and running along the line of Lot No. 65 S. 34-17 E. 252.1 feet to an iron pin; thence N. 56-57 E. 223.1 feet to an iron pin, joint rear corner of Lots 63 and 64; thence along the line of Lot No. 63 N. 49-24 W. 281.2 feet to an iron pin on Rockingham Road, joint front corner of Lots 63 and 64; thence along Rockingham Road S. 48-47 W. 117.5 feet to an iron pin; thence continuing with Rockingham Road S. 55-58 W. 32.5 feet to an iron pin, the beginning corner.
