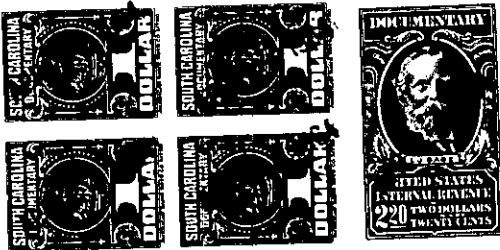
KNOW ALL MEN BY THESE PRESENTS, that We, M. L. Lanford, Jr. and William F. Lanford
