in the State aforesaid,

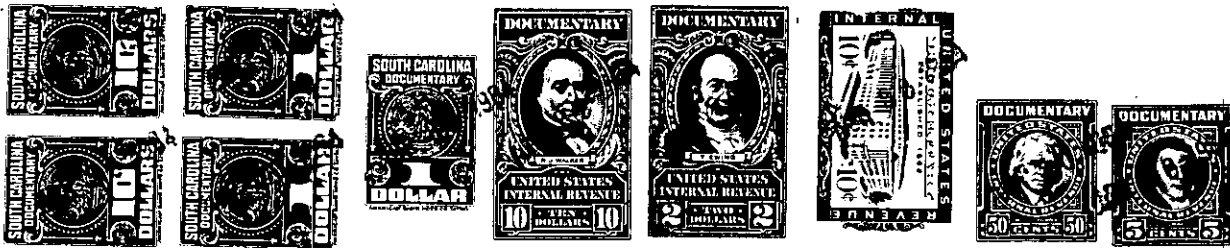
in consideration of the sum of Eleven Thousand Two Hundred and no/100 (\$11,200.00) DOLLARS,

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina and being shown as Lot No. 60 on a plat of the Revision of the Extension of Shamrock Acres, recorded in the RMC Office for Greenville County in Plat Book RR, Page 133, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Kingswood Drive at the joint front corner of Lots 59 & 60 and running thence with the common line of said lots N. 54-45 W. 146.5 feet to an iron pin; thence S. 37-20 W. 116.3 feet to an iron pin on the northeasterly side of County Cork Drive; thence with said Drive S. 53-0 E. 127.7 feet to an iron pin; thence around a curve at the intersection of County Cork Drive and Kingswood Drive (the chord of which is N. 82-0 E.) 28.3 feet to an iron pin on the northwesterly side of Kingswood Drive; thence with said Drive N. 37-0 E. 100 feet to the point of beginning.
