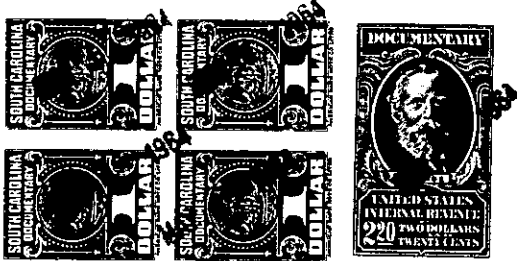

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as lot #98 on the eastern side of Cateham Way, of a subdivision known as Homestead Acres, Sec. II, as shown on a plat prepared by Piedmont Engineering Service, dated April 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book XX, at page 143, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Cateham Way, joint front corner lots #97 and #98, running thence along the joint line of these lots, N. 87-50 E. 175.0 feet to an iron pin; running thence S. 2-10 E. 90.0 feet to an iron pin at the joint rear corner lots #98 and #99; running thence S. 87-50 W. 175.0 feet to an iron pin on the eastern side of Cateham Way; thence along the eastern side of Cateham Way N. 2-10 W. 90.0 feet to an iron pin, point of beginning.
