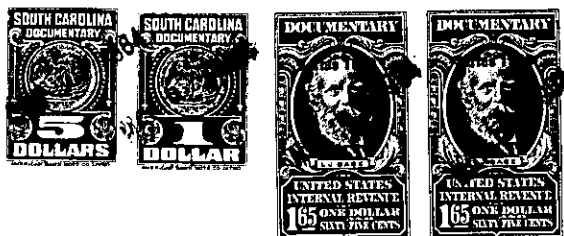
John R. Putnam, Jr., his heirs and assigns forever:
