in consideration of FOURTEEN THOUSAND FIVE HUNDRED (\$14,500.00)----- Dollars,

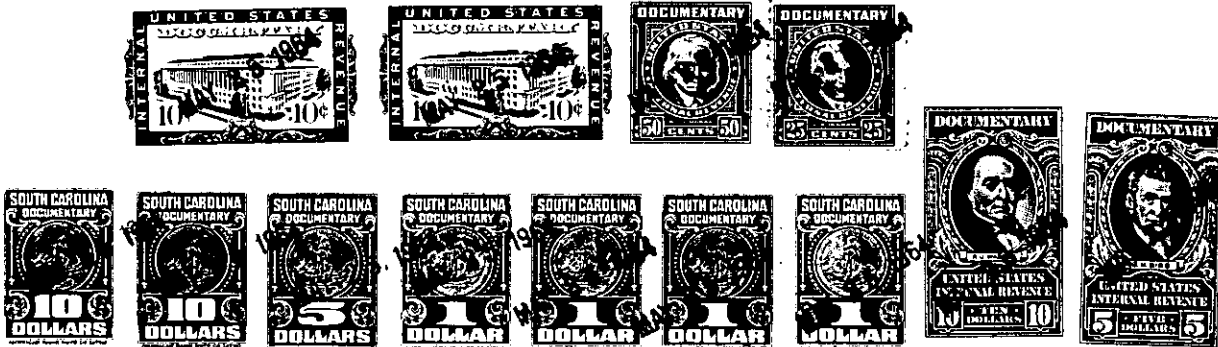
