- Hereby assign, transfer and set over to Bank, its successors and assigns, all monies now due and hereafter becoming due to the undersigned, as rental, or otherwise. and howsoever for or on account of that certain real property situated in the County of **GREENVILLE** _, State of South Carolina, described as follows:

ALL that lot of land with the buildings and improvements thereon, situate on the West side of Ashford Avenue, in the City of Greenville, in Greenville County, S. C., being shown as Lot No. 102 on plat of Vista Hills, made by Dalton & Neves Engineers, May 19 recorded in the RMC Office for Greenville County, S.C. in Plat Book P, pages 148 and May 1946, 149, and having according to said Plat the following metes and bounds, to wit:
