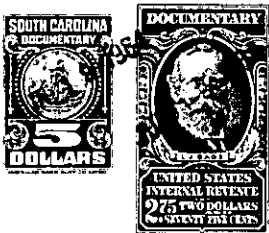

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot # 100 of an Addition to Wellington Green as shown on a plat thereof prepared by Piedmont Engineering Service, dated August 17, 1962, recorded in the R.M.C. Office for Greenville County in Plat Book RR at Page 99, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the eastern side of Sandown Lane (formerly known as Cora Lane) joint front corner lots #100 and #101, running thence along the joint line of these lots, S. 84-26 E. 170.0 feet to an iron pin; thence N. 2-00 W. 120.2 feet to an iron pin at the joint rear corner of lots #100 and #32; running thence along the joint line of these lots, N. 84-02 W. 154.2 feet to an iron pin on the eastern side of Sandown Lane (formerly Cora Lane); running thence along the eastern side of Sandown Lane, S. 5-34 W. 120.0 feet to an iron pin, point of beginning.
