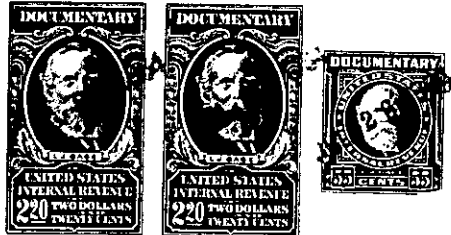
KNOW ALL MEN BY THESE PRESENTS That FIDELITY COMPANY, INC.
