All that piece, parcel or lot of land lying, being and situate in the County and State aforesaid, Fairview Township, Town of Fountain Inn, on the Northeast side of Thackston Street, known and designated as Lot No. 4 on a Plat prepared by C. O. Riddle, Surveyor, April 24, 1963, entitled "Property of W. Shell Thackston, Fountain Inn, S.
