Lewis Stover and Eleanor G. Stover, husband and wife,

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 85 on plat of Drexel Terrace dated April 1, 1961, and prepared by Piedmont Engineering Service, recorded in the Office of the R.M.C. for Greenville County in Plat Book QQ at page 177, and being more particularly described with reference to said plat as follows:

BEGINNING at a point on the westerly side of Kimberly Lane at the joint front corner of Lots 85 and 86 and running thence along said westerly side of Kimberly Lane S. 6-37 W. 100 feet to a point, joint front corner of Lots 84 and 85; thence turning and running along the common boundary of said lots, N. 82-40 W. 174.3 feet to a point in the line of Lot No. 96; thence turning and running along the line of Lots Nos. 96, 95, and 94 the following courses and distances: N. 10-30 W. 81.5 feet; N. 1-18 E. 15 feet to a point, joint rear corner of Lots Nos. 85 and 86; thence turning and running along the common boundary of said Lots S. 84-44 E. 199.2 feet to a point of beginning.

Said lot is subject to protective covenants for Drexel Terrace recorded on April 7, 1961, in the Office of the R.M.C. for Greenville County in Deed Book 671 at page 355 and to building set back line as shown on said plat.
