All that certain lot of land within the corporate limits of the City of Greenville, Greenville County, South Carolina, known and designated as the greater part of Lot 16 of Vista Hills Subdivision, as shown by plat recorded in Plat Book P, page 149, and having according to this plat, the following metes and bounds:

Beginning at an iron pin on the northwesterly side of Ridgcrest Drive at the joint front corner of Lots 16 and 17, which pin is 200 feet southwest of the northwest corner of the intersection of Ridgcrest Drive and Wayne Street, and running thence N 69-15 W 180 feet to an iron pin; thence N 18-37 E 90 feet to an iron pin; thence S 63-12 E 193 feet to a point on Ridgcrest Drive; thence along Ridgcrest Drive S 27-42 W 70 feet to the beginning.
