Know All Men by These Presents:

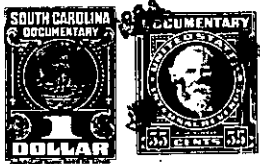
That We, JAMES H. GAINES and EVELYN O. GAINES,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. D. WILSON, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being the eastern one-half of Lot # 5 of Ellison River Lots according to a plat thereof by C. Edgar Williams, Jr., September 21, 1954, and being shown as Lot # 5B on plat prepared by Carolina Engineering and Surveying Company dated July 1, 1964, and recorded in Plat Book HHH, Page 11, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the northerly side of Sheerwood Road at the joint front corner of Lots 5B and 6 and running thence with the common line of said lots N. 22-00 W., 51 feet to a point on the high water line of South Saluda River; thence with the high water line of said river, S. 73-15 W., 60 feet to a point; thence a new line through Lot 5, S. 44-21 E., 69.6 feet to a point on the northerly side of Sheerwood Road; thence with said road, N. 54-30 E., 35 feet to the point of beginning and being a portion of the property conveyed to the grantors herein by deed recorded in Deed Book 628 at page 143.
