KNOW ALL MEN BY THESE PRESENTS That **DEMPSEY CONSTRUCTION COMPANY, INC.**,

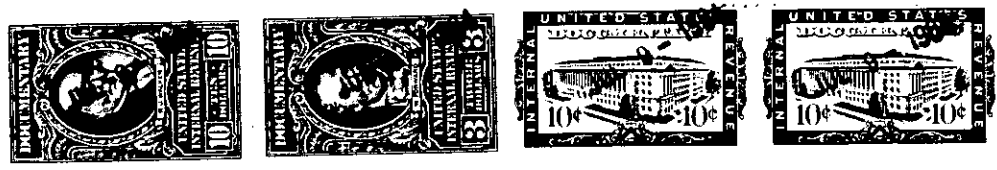
a corporation chartered under the laws of the State of **South Carolina**, and having its principal place of business at **Greenville**, in the State of **South Carolina**, for and in consideration of the

sum of **Twelve Thousand and No/100ths (\$12,000.00)** dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto **JAMES T. HARGROVE AND BETTY K. HARGROVE:**

All that certain piece, parcel or lot of land situate, lying and being on the Northern side of Patti Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 31 as shown on a plat of Staunton Heights, prepared by Dalton & Neves, Engineers, dated February, 1964, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book RR at page 167, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Patti Drive at the joint front corner of Lots Nos. 30 and 31, and running thence with the line of Lot No. 30 N. 13-0 E. 168.3 feet to an iron pin in the line of Tract No. 3; thence with the line of Tract No. 3 S. 72-30 E. 93.29 feet to an iron pin at the joint rear corner of Lots Nos. 31 and 33; thence with the rear lines of Lots Nos. 33 and 32 S. 13-0 W. 161 feet to an iron pin on the Northern side of Patti Drive; thence with the Northern side of Patti Drive N. 77-0 W. 93 feet to the point of beginning.
