the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Alexander K. Ramsay, his heirs and assigns forever:

All that piece, parcel or lot of land in Fairview Township, Greenville County, State of South Carolina containing 70.2 acres, more or less, according to survey of W.H. Riddle dated June 16, 1933 and being more particularly described according to said survey as follows:

Beginning at a stone, corner of W. H. Buchanan Property, and running thence with his line N. 8-45 E. 936 feet to an iron pin; thence N. 10 W. with same property 1605 feet to iron pin in branch; thence down the meanders of said branch N. 41-45 E. 327 feet to stake in branch; thence with branch N. 19 E. 76 feet to a stake in branch; thence with branch N. 49 E. 286 feet to iron pin; thence with property of Carrie Richardson, et al S. 60 E. 969 feet to iron pin; thence with property of Annie T. League S. 6 W. 3074 feet to iron pin in center of line of C. & W. C. Railway; thence with said Railway N. 62-30 W. 104 feet; thence N. 53-30 W. 320 feet to stake in center of Laurens-Greenville Highway; thence N. 56-45 W. 576 feet to the beginning.

The grantee is to pay all taxes against this property for the year 1940.
