All that lot of land on the northwest side of Pittman Circle, being shown as Lots # 6 & 7, on plat of property of J. A. Pittman & Maggie B. Pittman, made by Piedmont Engineering Service, July 1958, recorded in plat book SS page 33, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northwest side of Pittman Circle, at joint front corner of Lots # 5 & 6, and runs thence with the line of Lot # 5, N. 33-50 W. 136.8 feet to an iron pin; thence S. 56-10 W. 189 feet to an iron pin; thence with the line of Lot # 8, S. 33-50 E. 136.8 feet to an iron pin on the northwest side of Pittman Circle; thence along Pittman Circle N. 56-10 E. 189 feet to the beginning corner.
