Forty-Four Thousand Seven Hundred Fifty and no/100 ----the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and W. W. McEACHERN, his Heirs and Assigns forever;

ALE those two lots of land in Greenville County, South Carolina known and designated as Lots Numbers Fifty-Three (53) and Fifty-Four (54) of Section One (1) of Chanticleer, Inc. as shown by a plat thereof made by R. K. Campbell, dated September 29, 1962, and recorded in the R.M.C. Office for Greenville County in Plat Book WY at page 97; and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the southwestern side of West Seven Oaks Drive at the joint front corner of Lots 52 and 53 and running thence with the southwestern side of West Seven Oaks Drive, S. 71 - 27 E., 85 feet to a pin; thence still with the said Drive, S. 66 - 48 E., 35 feet to a pin at the joint front corner of Lots 53 and 54; thence still with said Drive, S. 66 - 48 E., 102.7 feet to a pin; thence still with said Drive, S. 67 - 35 E., 27 feet to a pin at the joint front corner of Lots 54 and 55; thence with the line of Lot 55, S. 16 - 58 W_{*}, 207.7 feet to a pin at the joint rear corner of Lots 54 and 44; thence with the rear line of Lot 44, N. 75 - 48 W., 120 feet to a pin at the joint rear corner of Lots 53 and 45; thence with the rear line of Lot 45 N. 75 - 48 W., 100 feet to a pin at the joint rear corner of Lots 52 and 53; thence with the line of Lot 52, N. 9 - 32 E., 239.8 feet to the beginning corner.
