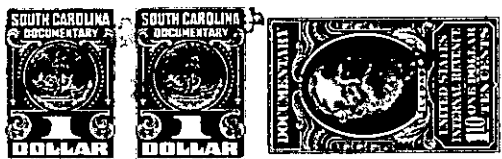

All that certain piec ,parcel or lot of land in the State of South Carolina, County of Greenville, situate at the western corner of Ivy Drive and Greenbrier Drive Austin Township, being shown and designated as Lot No. 29 of Greenbrier , as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "QQ" , Page 65 and having , according to said plat , the following metes and bounds , to-wit:

BEGINNING at an iron pin on the northwestern side of Greenbrier Drive at the joint front corner of Lots Nos. 29 and 30 and running thence with the line of Lot No. 30 N. 36-20 W. 208 feet to pin at rear corner of Lot No. 34 ; thence with the line of Lot No. 34 , N. 53-40 E. 200 feet to pin on Ivy Drive ; thence with the southwestern side of Ivy Drive , S. 36-20 E. 185 feet to pin ; thence with the intersection of Ivy Drive and Greenbrier Drive and following the curvature thereof , the chord being S. 8-40 W. 35.4 feet , to pin ; thence with the northwestern side of Greenbrier Drive , S. 54-30 W. 175 feet to the point of beginning.

The above described property is the same conveyed to Grantors by deed dated October 12, 1962 and being recorded in the R. M. C. Office for Greenville County Deed Book 725 at Page 478.
