in consideration of the sum of \$10.00 and other Considerations to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

HAROLD WILLIAM PAYNE and BONNIE P. PAYNE, their heirs and assigns forever,

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the Northeast side of Pinckney Street in the City of Greenville, County of Greenville, State of South Carolina, being shown as LOT NO. 21 on plat of the W. P. McBee Home Place, made by J. M. Southern, Surveyor, May 16, 1902, recorded in the RMC Office for Greenville County in Plat Book A, at page 83 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northeast side of Pinckney Street at joint front corner of Lots 19 and 21, being the corner of property now or formerly of L. M. Briggs, and running thence along the line of Lot 19, North 39-1/2 East 146 feet to an iron pin at corner of property, now or formerly of Herbert Hammond; thence along the Hammond line, North 33-1/2 West 52 feet to an iron pin; thence along the line of Lot No. 23, South 46-00 West 161 feet to an iron pin on the Northeast side of Pinckney Street; thence along the Northeast side of Pinckney Street, South 59-1/2 East 64-1/2 feet to the beginning corner.
