a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville, S. C. in the State of South Carolina, for and in consideration of the

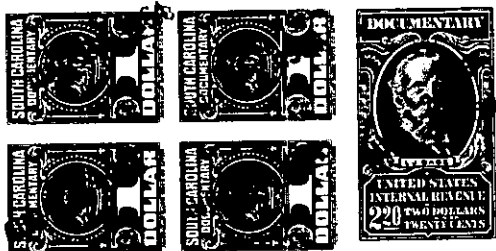
sum of One Thousand Six Hundred and Fifty and No/100 (\$1650.00) dollars,
