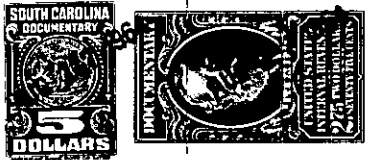
in consideration of the sum of Twenty Three Hundred and no/100 (\$2300.00) ----- DOLLARS,

SHELTON and DOROTHY M. SHELTON, their heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot # 95 and a portion of Lot # 94 on a plat of Western Hills recorded in the R. M. C. Office for Greenville County in Plat Book "QQ" at pages 98-99, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Tucson Drive at the joint front corner of lots # 95 and 96 and running thence with the common line of said lots S. 23-55 E., 182 feet to an iron pin; thence N. 71-32 E., 145 feet to an iron pin; thence a new line through lot # 94, N. 23-20 W., 199.5 feet to an iron pin on the southerly side of Tucson Drive; thence with said Drive S. 65-52 W., 50.7 feet to an iron pin; thence continuing with said Drive, S. 63-17 W., 54.5 feet to an iron pin; thence continuing with said Drive, S. 64-19 W., 35.6 feet to the point of beginning.

The above lot is conveyed subject to recorded restrictions applicable to Western Hills and to the set back line as shown on said plat.
