the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, on the northeastern side of East Sable Court, being shown as Lot No. 14 on a plat of Blue Mountain Park, recorded in the R.
