Herthy assign, transfer and set over to Bank, its successors and assigns, all monies now due and hereafter becoming due to the undersigned, as rental, or otherwise. and howsoever for or on account of that certain real property situated in the County of GREENVILLE _, State of South Carolina, described as follows: Book KK - Page 199

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as 1ot No. 24, according to a plat of preperty of Forestdale Heights prepared by R. K. Campbell, Surveyor, December 1956 and revised November, 1958, recorded in the R. M. C. Office for Greenville County in Plat Book KK at Page 199, and having, according to said plat, the following metes and bounds, to wit:

- 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
