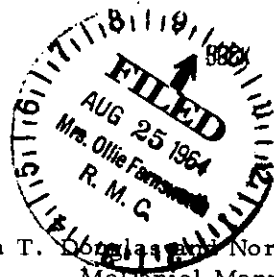

All that lot of land, situate on Rockingham Road in Greenville County, State of South Carolina, being shown as Lot No. 27 Rockingham Road, on plat of Barksdale subdivision made by Dalton & Neves, Engineers, December 1959, recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "QQ" Pages 118-119 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on Rockingham Road, joint front corner of Lots 26 and 27 and running along Rockingham Road S. 16-42 E. 150 feet to an iron pin, joint front corner of Lots 27 and 28; thence along the line of Lot 28 N. 69-0 E. 250 feet to an iron pin; thence N. 15-44 W. 120 feet to an iron pin; thence along the line of Lot 26 S. 75-37 W. 250.9 feet to an iron pin, the beginning corner.
