We, L.V. Allen and Lillie T Allen

in consideration of Five Hundred and No/100 ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto George Thompson, his heirs and Assigns forever.

All that certain piece, parcel or lot of land situate and being in Oaklawn Township, in the County of Greenville, State of South Carolina, lying on the East side of a County Road, containing 8.96 acres, more or less, and according to a plat from a survey by John C Smith November 13 1959, being more particularly described as follows to wit ;

BEGINNING at a nail in center of said road running thence N-41-00 W 676 feet to a point ; thence N-35-W 140 feet to a point, thence N-17-15 W 4230 feet to a point thence N-1-W 200 feet to a point; thence N-16-09 W 168.6 feet to a point thence S-81-W 83.8 feet to cement mon ; thence the branch southeasterly to an iron pin ; thence S-10-00-W 613 feet to beginning corner.
