release unto MAX E. WHATLEY and NANCY R. WHATLEY, their Heirs and Assigns:

ALL that lot of land in Greenville County, South Carolina, known and designated as Lot Number Forty-Six (46) of Section One (1) of Chanticleer, Inc. as shown by a plat thereof made by R. K. Campbell, dated September 29, 1962, and recorded in the R.M.C. Office for Greenville County in Plat Book YY at page 97; and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of West Seven Oaks Drive at the joint front corner of Lots 46 and 47 and running thence with the northern side of West Seven Oaks Drive, N. 74 - 53 W., 56.2 feet to an iron pin; thence still with the northern side of West Seven Oaks Drive, N. 78 - 07 W., 60 feet to an iron pin, joint front corner of Lots 46 and 45; thence with Lot 45, N. 11 - 56 E., 227.3 feet to an iron pin at the rear corner of Lot 52; thence with the rear line of Lot 52, S. 75 - 48 E., 100 feet to an iron pin at the rear corner of Lot 47; thence with Lot 47, S. 16 - 02 W., 228.5 feet to the beginning corner.
