TIMMONS, JR. in the State aforesaid, in consideration of the sum of ONE THOUSAND SEVEN HUNDRED FORTY-FIVE AND NO/100 (\$1,745.00) DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ULDRICK CONSTRUCTION CO., INC, ITS SUCCESSORS AND ASSIGNS:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 19 of a subdivision known as McSwain Gardens, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Page 75, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southwestern side of Shannon Drive at the joint front corner of Lots 18 and 19 and running thence with the joint line of Lots 18 and 19 S 43-40 W approximately 225 feet to a point in a branch, the joint rear corner of Lots 18 and 19; thence with said branch as a line approximately N 34-20 W approximately 97 feet to a point, the joint rear corner of Lots 19 and 20; thence with the joint line of Lots 19 and 20 N 43-40 E approximately 203.3 feet to a point on the Southwestern side of Shannon Drive at the joint front corner of Lots 19 and 20; thence with the Southwestern side of Shannon Drive S 51-15 E 17.3 feet to a point; thence continuing with the Southwestern side of Shannon Drive S 46-20 E 77.7 feet to the point of beginning.
