sum of One Thousand Four Hundred Fifty and no/100 (\$1450.00) dollars,

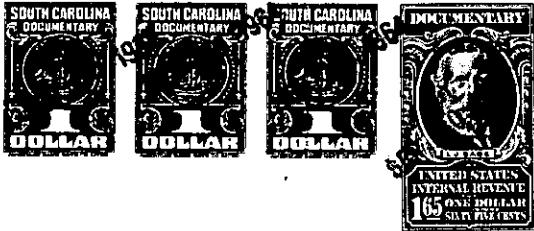
