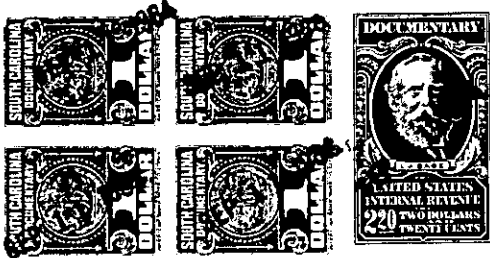
KNOW ALL MEN BY THESE PRESENTS, that **PIEDMONT LAND CO.**

A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of Sixteen Hundred Twenty and no/100 ----- (\$1620.00) ----- Dollars,

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto Larry G. Shaw, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #60 of a subdivision known as Homestead Acres, Section I, as shown on a plat prepared by J. Mac Richardson, Engineer, dated November 1959, and recorded in the R.M.C. Office for Greenville County in Plat Book RR at Page 35, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Hampshire Drive at the joint front corner of Lots #59 and #60 and running thence N2-15W 211.2 feet to an iron pin; thence S87-50W 90 feet to an iron pin at the joint rear corner of lots #60 and #61; thence S2-10E 200 feet to an iron pin on the Northern side of Hampshire Drive; thence along the Northern side of Hampshire Drive S85-18E 90.8 feet to an iron pin, point of beginning.
