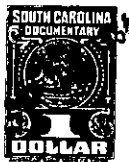

All that piece, parcel or lot of land situate, lying and being in Chick Springs Township, Greenville County, State of South Carolina, on the western side of Elaine Avenue and being known and designated as Lot No. 16 on plat of property of William M. Edwards recorded in the R. M. C. Office for Greenville County in Plat Book "S", at Page 12, said lot fronting 75 feet on the western side of Elaine Avenue and running back to a depth of 272 feet on the north side and to a depth of 269.1 feet on the south side and being 75.05 feet across the rear.
