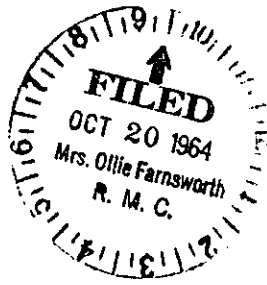

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot 116, as shown on a plat of Section 1, Caroline Court, dated September 1953 by Dalton & Neves Engineers, recorded in the R.
