KNOW ALL MEN BY THESE PRESENTS, that I, Richard Arthur Ashmoffer Wille CO. S. C.



ALL that lot of land in the County of Greenville, State of South Carolina shown as lot no. 43 on plat of Edwards Forest of record in the R.M.C. Office for Greenville County in plat book EE at page 105 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of Edwards Road, at the joint front corner of lots nos. 42 and 43 and running thence along the line of lot no. 42, S. 70-37 W. 212.4 feet to an iron pin; thence N. 19-23 W. 100.7 feet to an iron pin at the rear corner of lot 44; thence with the line of said lot, N. 70-37 E. 168feet to an iron pin on the western side of Edwards Bood, thereas N. 70-37 E. 168feet to an iron pin on the western side of Edwards Road; thence following said road, the following courses and distances, to-wit: S. 49-11 E. 13.8 feet to an iron pin; thence S. 42-13 E. 96.6 feet to the point of beginning.

Also, ALL that lot of land in the County of Greenville, State of South Carolina, known as part lot 44 on plat of Edwards Forest recorded in the R.M.C. Office for Greenville County in plat book EE at page 105 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of Edwards Road at the joint front corner of lots nos. 43 and 44 and running thence along the line of lot no. 43 S. 70-37 W. 168 feet to an iron pin at the joint rear corner of lots 43 and 44; thence on a new line approximately N. 60 E. 145 feet, more or less, to an iron pin on the western side of Edwards Road; thence with the said road S. 49-11 E. 35 feet to the point of beginning. Said description describes a triangular strip of land adjacent to lot 43 and is a portion of that property conveyed to me in deed book 756 at page 567.

This is the same property conveyed to the Grantor herein by deed of Russell C. Ashmore dated June 23, 1958 and recorded in the R.M.C. Office for Greenville County, South Carolina, in deed book 600 at page 493. (applies to first parcel.)
