in consideration of the sum of Nine Thousand and No/100 (\$9,000.00)----- DOLLARS,

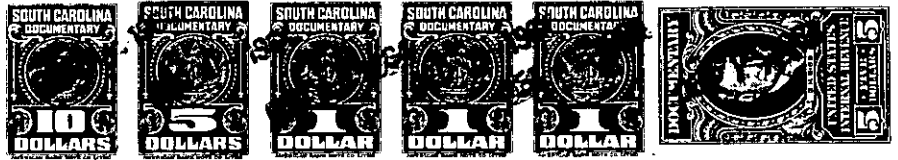

INGRAM and MAZELL J. INGRAM, Their Heirs and Assigns, Forever:

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the South side of East Avenue and known and designated as Lot No. 7 on plat of land of Emmala B. and Elizabeth E. Jones, made by J. E. Sirrine, dated October, 1895, and recorded in the RMC Office for Greenville County, S. C. in Plat Book E, Page 37 and 38, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of East Avenue at the joint front corner of Lots 6 and 7 and runs thence along the line of Lot 6, S. 13-45 E., 208 feet to an iron pin; thence N. 76-15 E., 64 feet to an iron pin; thence along the line of Lot No. 8, N. 13-45 W., 204.5 feet to an iron pin on the South side of East Avenue; thence along the South side of East Avenue S. 80-15 W., 64 feet to the beginning corner.
