the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Bertha A. Seay, Her Heirs and Assigns,

All that certain piece, parcel or lot of land lying and situated in the County and State aforesaid, Bates Township, on the east side of G & N Railroad, adjoining the land of Bessie Swaney and being more fully described as follows:

BEGINNING at Railroad Splice at the corner of Landers and Bessie Swaney and running thence S. 44 E. 83.5 feet to a stake; thence S. 44 E. 247.3 feet to the center of road; thence S. 58 E. 108.8 feet to the center of Hart Cut Road; thence S. 36-15 W. 117.8 feet to the center of bridge over railroad; thence with railroad N. 61-40 W. 124 feet; N. 71-45 W. 187 feet; N. 73-20 W. 108 feet; N. 67 W. 107 feet; N. 60 W. 113 feet; N. 55-05 W. 94 feet; thence N. 80 E. 436 feet to the beginning corner, and containing 3.06 acres, more or less.

ALSO: All that piece, parcel or lot of land situate, lying and being in Bates Township, Greenville County, State of South Carolina and having the following metes and bounds, to-wit:

BEGINNING on a small poplar near the spring; thence N. 58-00 E. 110 feet to stake; thence S. 45-30 E. 146 feet to a stake; thence S. 47-30 W. 262 feet to a stake; thence N. 2-15 E. 120 feet to a stake; thence N. 27-45 W. 108 feet to a stake on the McGill line; thence N. 75 E. 46 feet to the small poplar, the point of beginning, containing 0.7 of an acre, more or less.
