All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southerly side of Patti Drive, near the City of Greenville, S. C., being known and designated as Lot No. 9 on plat of Staunton Heights, as recorded in the RMC Office for Greenville County, S. C., in Plat Book RR, page 167, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Patti Drive, said pin being the joint front corner of Lots 9 and 10 and running thence with the common line of said lots S 13-0 W 198.1 feet to an iron pin, the joint rear corner of Lots 9 and 10; thence S 81-46 E 73.9 feet to an iron pin; thence S 81-08 E 6.35 feet to an iron pin, the joint rear corner of Lots 8 and 9; thence with the common line of said Lots N 13-0 E 191.7 feet to an iron pin on the southerly side of Patti Drive; thence with the southerly side of Patti Drive N 77-0 W 80 feet to an iron pin, the point of beginning.
