Alexander, her heirs and assigns forever:

All that certain piece, parcel or lot of land, lying and being on the easterly side of Rocky Slope Road in the City of Greenville, S. C., and being designated as Lot No. 2 on the plat entitled "Section A, Portion of Property of Elsie F. Hayes," made by Dalton & Neves, dated July 1956, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Rocky Slope Road, joint front corner of Lots 1 and 2, and running thence along the common line of said lots N 65-43 E 213.4 feet to an iron pin; thence N 17-50 W 100 feet to an iron pin, joint rear corner of Lots 2 and 3; thence along the common line of said lots S 65-53 W 229.2 feet to an iron pin on the easterly side of Rocky Slope Road; thence along said road S 27-03 E 100 feet to an iron pin, the point of beginning.

GRANTOR TO PAY 1964 TAXES.

This conveyance is made subject to the following restrictions:

- (1) No building shall be erected nearer than 40 feet to the front lot line, nor nearer than 10 feet to the side line.
(2) No lot shall be used except for residential purposes. No building shall be erected, altered, placed or permitted to remain on any lot other than one detached single family dwelling not (continued on reverse side)

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

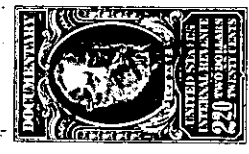
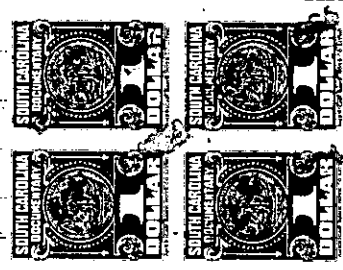
