I, E. INMAN, Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Shelda Jean T. Head

on or about the 16th day of December in the year of
our Lord nineteen hundred and Sixty Four exhibited her
complaint in the Court of Common Pleas for the County aforesaid, against
John Roy Tanner, an infant over the age of fourteen years

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard
on the 21st day of December 1964,
and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and
decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN, Master in and for
the County aforesaid, to Robert C. Miller

for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear;

NOW, Therefore, Know all Men by these Presents, that I, E. INMAN, Master, in and for the County of
Greenville aforesaid, by virtue of the aforesaid decree,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto
the said Robert C. Miller, all the right, title and interest of the
minor defendant, John Roy Tanner, in and to the following described
real estate:

"ALL that piece, parcel or lot of land in Oaklawn Township,
Greenville County, State of South Carolina, and having the following
metes and bounds: BEGINNING on stone on West banks of Reedy River
South 68 1/2 West 27.65 to stone 3x on Fork Shoals Road; thence with
road South 6 1/2 East 8.50 to stone 3x; thence South 48 1/2 West 0.50
across road to stone 3x; thence with said road South 13 3/4 East 9.86
to stone 3x; thence North 79 1/2 East 8.71 to stone 3x; thence North
60 1/2 East 15.22 to stone 3x on river; thence with meanderings of
said river to BEGINNING point; this is the same tract of land
conveyed to R. W. Poole by J. L. Rogers, deed dated September 11, 1930,
recorded in office of Register of Mesne Conveyance in and for Green-
ville County in Volume 156 at page 10, one-half interest coming to the
grantor herein under the will of R. W. Poole, deceased; the other one-
half being deeded to the C. C. Poole by E. H. Poole; and being the
same identical land conveyed to Roy R. Tanner and Mary Couch Tanner
by C. C. Poole by deed dated August 29, 1945, and recorded in Book of
Deeds 279, at page 391, in the office of the Register of Mesne
Conveyance for Greenville County, South Carolina."

This deed is made pursuant to the Order of Court and the Master is
directed therein to convey the undivided three-fourths interest of
the minor defendant in said property to Robert C. Miller. The
