to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Virgil Henderson, his heirs and assigns forever:

All that certin piece, parcel or tract of land in State and County aforesaid on the east side of the Miller Road and the west side of Gilders Creek, containing 11.4 acres, more or less, and being identified as Tract 4 on plat entitled "Property of Tillman Henderson" prepared by C. C. Jones, Civil Engineer, in November, 1964 (which plat will be recorded herewith) and having according to said plat the following metes and bounds, to-wit:

BEGINNING at point in the center of the Miller Road (leading from Woodruff, S. C. to Mauldin, S. C.), joint front corner of Tracts 4 and 5; thence S. 80-56 E. 500 feet to an iron pin; thence S. 63-16 E. 1,043 feet to a point in the center of Gilders Creek (which point is 10 feet S. 63-16 E. from an iron pin on the bank of said creek); thence with the center of said creek as the line along an irregular course (the chord of which is S. 5-12 W.) 122.3 feet, more or less, to a point in the center of said creek; thence continuing along an irregular course following the center of said creek (the chord of which is S. 15-00 W.) 200 feet to a point, the joint rear corner of Tracts 3 and 4; thence N. 63-16 W. (crossing an iron pin on the west bank of said creek) 1,046 feet to an iron pin; thence N. 80-56 W. 150 feet to an iron pin at the rear of property of Lynch; thence N. 80-56 W. 350 feet to a nail and cap in the center of said road (which point is 27 feet N. 80-56 W.) from an iron pin on the bank of said road to point of beginning.

SUBJECT, HOWEVER, to a 50 foot easement reserved for road purposes along the south-western boundary of said Tract, the same extending along the property of Lynch 350 feet and thence along Tract 3 for a distance of 75 feet the same being 50 feet in width as the line parallels Lynch's property, and thence a curving course in a southeasterly direction from a point opposite the rear corner of Lynch to a point on the northern boundary of Tract 3, 75 feet from the Lynch corner, all of which is shown more fully on said plat, reference to which is craved. It is understood that the Grantor purposes to deed this 50 foot easement strip to Greenville County for road purposes in order to acquire ingress and egress to Tract 3. Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
