for consideration of Four Thousand Nine Hundred Thirty Dollars (\$4,930)

RESOLVED, FURTHER. That the President, or a Vice President, and the Chief Engineer or Assistant Chief Engineer of this Company be, and each of them hereby is authorized and directed to take such other and further action and to execute such certificates, deeds or other writings as may be necessary or expedient to obtain the release of and to convey said property to said purchaser for said consideration, freed, clear and forever discharged from the lien of the Mortgage hereinabove referred to.
