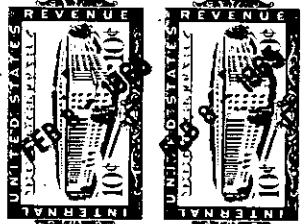

KNOW ALL MEN BY THESE PRESENTS, that I, J. Odell Shaver

in consideration of Fourteen Thousand and 00/100 (\$14,000.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto H. Carlos & Winnie H. Shaver, their heirs and assigns forever:

ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, near the Town of Mauldin, and being known and designated as Lot Number 2 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R.M.C. Office for Greenville County in Plat Book BBB at Page 15, and having the following metes and bounds, to-wit:

BEGINNING at a point on the Northeastern side of Bethel Drive at the joint front corner of Lots 1 and 2 and running thence N. 42-09 E. 175 feet to the joint rear corner of Lots 2 and 11; thence N. 47-51 W. 95 feet to a point at the joint rear corner of Lots 2 and 3; thence S. 42-09 W. 175 feet to the joint front corner of Lots 2 and 3; thence S. 47-51 E. 95 feet to the point of beginning.

This deed is executed subject to existing and recorded restrictions and rights-of-way.
