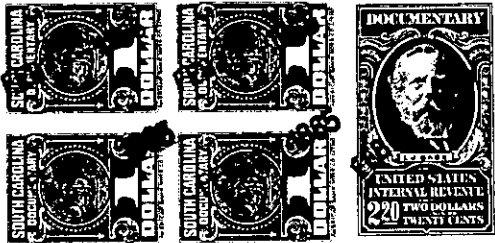
in consideration of Two Thousand and No/100 ----- Dollars,
