

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon situate on the East side of Sycamore Drive, in the City of Greenville, County of Greenville, State of South Carolina, shown and designated as Lot No. 161 on plat of East Lynne Addition made by Dalton & Neves, Engineers, May 1933, and recorded in the RMC Office for Greenville County, S.
