KNOW ALL MEN BY THESE PRESENTS, that I, Ray M. Knight,

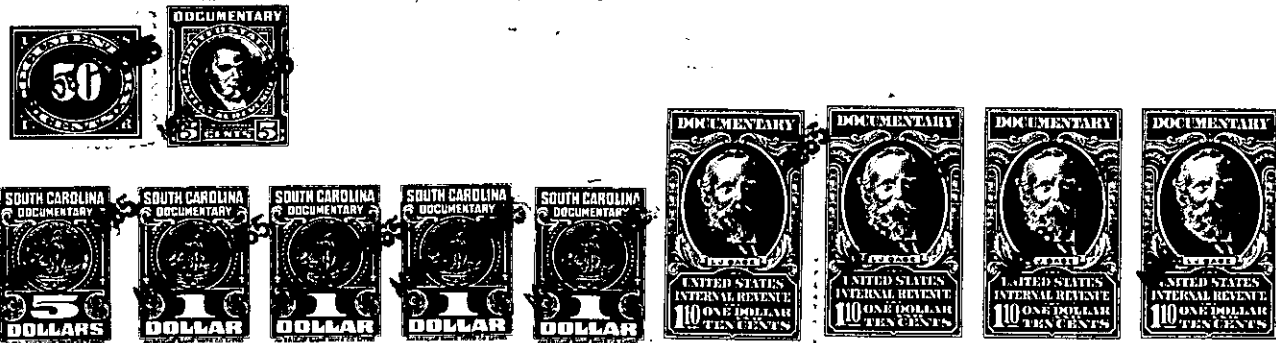
in consideration of Four Thousand Four Hundred Eighty-Two and 74/100----- Dollars,
and assumption of mortgage
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Lloyd W. Gilstrap, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in Greenville Township, County of Greenville, State of South Carolina, near Farmers Oil Mill about 2 1/2 miles from the Greenville County Courthouse and situate at the southeastern corner of the intersection of Page Drive and Old White Horse Road and being shown on plat of Property of grantor prepared by J. C. Hill dated December 14, 1959 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Old White Horse Road and running thence with the eastern side of said Road N. 6 E. 158.4 feet to an iron pin in the center of Page Drive; thence with the center line of said Drive N. 58-30 E. 47 feet to a nail in cap; thence S. 29-30 E. 119 feet to an iron pin; thence S. 55-30 W. 140.1 feet to the point of beginning.

The above is the same property conveyed to the grantor by deed recorded in Deed Book 642, at Page 25.

As part of the consideration for this conveyance the grantee assumes and agrees to pay the balance due on the mortgage over the above property to Independent Life and Accident Insurance Company recorded in Mortgage Book 813, at Page 73, the balance now due and owing being \$3,017.26.
