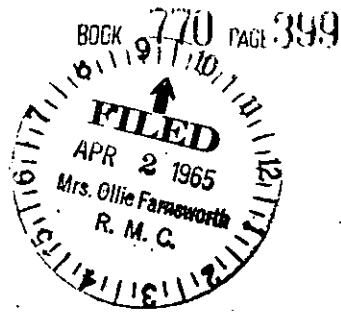

in consideration of -- Six Hundred Seventy-five and no/100 (\$675.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto  
Horace M. Dooley and Edith P. Dooley, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 121 Bellwood Road as shown on a Plat of Section 2, Bellwood Estates, dated 1955 by Woodward Engineering Company, recorded in the R. M. C. Office for Greenville County in Plat Book GG, at Page 50, and having according to said plat, the following description, to-wit:

BEGINNING at an iron pin on Bellwood Road joint front corners of lots 120 and 121 and running thence 80 feet along Bellwood Road to an iron pin joint front corners of lots 121 and 122 running thence 196.0 feet, more or less, along the side line of lot 122 to an iron pin joint rear corners of lots 121 and 122; running thence 80 feet along the rear line of lot 121 to an iron pin joint rear corners of lots 120 and 121; running thence 194.6 feet, more or less, along the side line of lot 120 to an iron pin at joint front corners of lots 120 and 121 on Bellwood Road, the point of beginning.

NO residence shall be built on any lot costing less than Seven Thousand Five Hundred (\$7,500.00) Dollars; no residence shall be built on said lots nearer than twenty-five (25) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.
