All that piece, parcel or lot of land situate, lying and being on the Northwestern side of Cherrylane Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 43 as shown on a plat of Farmington Acres, prepared by Carolina Engineering and Surveying Co., dated December, 1962, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book RR at pages 106 and 107, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northwestern side of Cherrylane Drive at the joint front corner of Lots Nos. 42 and 43, and running thence with the line of Lot No. 42 N. 37-15 W. 255.7 feet to an iron pin; thence S. 62-29 W. 70.5 feet to an iron pin; thence S. 44-31 W. 20.7 feet to an iron pin at the joint rear corner of Lots Nos. 43 and 44; thence with the line of Lot No. 44 S. 37-15 E. 263.7 feet to an iron pin on the Northwestern side of Cherrylane Drive; thence with the Northwestern side of Cherrylane Drive N. 52-45 E. 90 feet to the point of beginning.
