ALL that parcel or strip of land situate on the Northwest side of Pittman Circle, near the City of Greenville, in Greenville County, South Carolina, and having according to a survey made by H. C. Clarkson Jr., Surveyor, March 29, 1965, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book III , Page 97, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northwest side of Pittman Circle in line of other property of Grantees herein, N. 0-23 W., 31.3 feet to an iron pin; thence still along line of other property of Grantees, N. 27-00 W., 3 feet to an iron pin; thence along line of property now or formerly of Henry McCauley, N. 56-10 E., 36.45 feet to an iron pin on the Northwest side of Pittman Circle; thence with the curve of Pittman Circle (the chord being S. 36-45 W., 30 feet to an iron pin; thence still with the curve of Pittman Circle (the chord being S. 19-36 W., 32.1 feet) to the beginning corner.

THIS strip of land is formerly shown as a part of Pittman Circle by plat of property of the Grantees, recorded in Plat Book RR, Page 143, but in laying out Pittman Circle on the ground, it was not located as shown on said plat and it is the intent of the Grantor to convey to the Grantees any land which Grantor owns lying between their present property line and Pittman Circle.
